



## Town of Kearney Accessibility Plan

### **1. Executive Summary**

The purpose of the Ontarians with Disabilities Act, 2001 (ODA) is to improve opportunities for people with disabilities and to provide for their involvement with the identification, removal and prevention of barriers to their full participation in the life of the province. The ODA mandates that each municipality prepare an accessibility plan.

The Town of Kearney is committed to promoting a barrier free municipality for all employees, ratepayers, stakeholders, visitors and investors.

This report outlines the Town of Kearney's commitment to improvement of access to municipal facilities; both physical and electronic.

### **2. Purpose**

The aim of this report is to identify all barriers to people with disabilities who utilize the facilities and services of the Town and to prepare a forecast for the correction of such barriers as determined.

### **3. Objectives:**

This report describes:

1. The process for identification, removal and prevention of barriers to persons with disabilities;
2. Review previous initiatives undertaken to remove and prevent barriers for people with disabilities;
3. List the facilities, policies, programs, practices and services the Town of Kearney will need to review in the coming year to identify barriers for people with disabilities; and
4. Describe ways in which this plan will be made available to the public

### **4. Barrier Identification Process**

Council and staff will review barriers for people with disabilities, during the formulation of policies and the capital budgeting process and through participation in an annual audit of the Town's facilities and Accessibility Plan.

A copy of the plan will also be posted on the Town of Kearney web-site with an e-mail link to encourage public input. Recommended changes will be implemented where feasible and/or as extracted from the website for the next annual revision period. This plan is not considered to be comprehensive in nature and therefore is subject to continuous updates.

### **5. Initiatives Previously Undertaken to Remove Barriers**

- Reconstruction of sidewalks and curb cuts in the downtown core
- Winter control on sidewalks in the downtown core
- Removal of snow at core downtown intersections
- Appropriately assigned accessible parking space(s) provided at Community Centre
- Community Centre is equipped with an accessible washroom and power assisted doors throughout the interior and exterior of the building.
- Railings installed along boardwalk at Lion's Park Pavilion

## 6. Facilities

The Kearney Community Centre located at 8 Main Street, is a wheelchair accessible building, with power assisted doors and designated handicapped parking space(s).

The Community Centre consists of the follow:

- Municipal Office;
- Council Chambers/Seniors Room;
- Kitchen(s)
- Washrooms/showers
- Library;
- Gymnasium; and
- Ministry of Natural Resources Parks Office
