- 4. Council Discussion with Laroque Elder Architects and Bradanick Contracting regarding KCC Renovations took place.
  - James @ Bradanick noted supply issues and resolutions as well as the goals met to date.
  - Jeff @ LEA explained the process being followed on the project and explained things that have been accomplished thus far
  - Discussions between Council and the contractors covered:
    - Septic system issues
    - o The possibility of relocating the public washrooms
    - The consideration of flooring and finishes such as acoustic treatments, PA and audio visual systems
  - Jeff @ LEA spoke of change orders, explaining how they worked, and the manner in which costs and savings were observed using the cash allowances built in to the project budget.

Councillors, team members from Larocque Elder Architects and contractor toured the construction site.
