(ii) Report and Resolution re: E-Permitting Res. No. 10(a)(ii)/25/02/2022 Liz Stermsek, Paul Ziraldo

WHEREAS Local Authority Services (LAS) is the business services arm of the Association of Municipalities of Ontario (AMO) and is mandated to provide valuable programs and services to Ontario's municipalities and the broader public sector. On behalf of its partner organizations, LAS facilitates a competitive solicitation and contracting process based on the needs of municipalities;

AND WHEREAS LAS offers competitively-priced and sustainable business services to Ontario municipalities and the broader public sector;

AND WHEREAS the Municipal Property Assessment Corporation (MPAC) is an independent, not-for-profit corporation funded by all Ontario municipalities;

AND WHEREAS MPAC is responsible for ingesting building permit information in order to deliver timely new assessment to Ontario municipalities to support the generation of new tax

AND WHEREAS AMO/LAS and MPAC partnered to search for a single, digital, end to end electronic permitting (e-permitting) solution through LAS' RfP process;

AND WHEREAS AMO and MPAC are seeking expressions of interest to participate in a oneyear pilot project with e-permitting provider 'Cloudpermit', to demonstrate the benefits of epermitting in Ontario;

AND WHEREAS municipalities that are selected for the pilot project will benefit by receiving six (6) months of service with the municipality also responsible for six (6) months of costs for participating in the pilot project, using the Cloudpermit system;

AND WHEREAS the Town of Kearney is committed to digitizing processes to increase efficiencies of Kearney's administrative functions, including e-permitting;

NOW THERFORE BE IT RESOLVED that the Council of the Corporation of the Town of Kearney supports:

- continuing to support the requirements set in the Ontario Building Code Act to ensure adequate measures are in place to administer the Ontario Building Code;
  - 1) authorizing the Chief Building Official to proceed with involvement in the AMO/LAS/-MPAC pilot project, including the implementation of 'Cloudpermit' E-Permitting Software; and
  - 2) delivering a project commitment to AMO/LAS with funding dollars being committed to support this pilot project involvement. CARRIED
