7.6 Support Resolution South Bruce Peninsula Re Support for Comprehensive Review of Social and Economic Prosperity

WHEREAS current provincial-municipal fiscal arrangements are undermining Ontario's economic prosperity and quality of life;

AND WHEREAS nearly a third of municipal spending in Ontario is for services in areas of provincial responsibility, and expenditures are outpacing provincial contributions by nearly \$4billion a year;

AND WHEREAS municipal revenues, such as property taxes, do not grow with the economy or inflation;

AND WHEREAS unprecedented population and housing growth will require significant investments in municipal infrastructure;

AND WHEREAS municipalities are being asked to take on complex health and social challenges – like delivering long term care services, homelessness and affordable housing options, addressing the mental health and additions crises, and other social services;

AND WHEREAS inflation, rising interest rates, and provincial policy decisions are sharply constraining municipal fiscal capacity;

AND WHEREAS property taxpayers – including people on fixed incomes and small businesses can't afford to subsidize income re-distribution programs for those most in need:

AND WHEREAS the Province can, and should, invest more in the prosperity of communities:

AND WHEREAS municipalities and the Provincial government have a strong history of collaboration;

THEREFORE BE IT RESOLVED THAT The Town of Kearney requests that the Province of Ontario commit to undertaking the Association of Municipalities of Ontario, a comprehensive social and economic prosperity review to promote the stability and sustainability of municipal finances accress Ontario;

AND FURTHER that this resolution be sent to The Premier of Ontario Doug Ford, Hon. Peter Bethlenfalvy – Ontario's Minister of Finance, Graydon Smith – MPP for Parry Sound Muskoka, the Association of Municipalities of Ontario and all other Ontario municipalities.

7.7 Support Resolution Orangeville Police Services Board Resolution reg. Intimate Partner Violence

WHEREAS the Orangeville Police Services Board recently passed a resolution regarding Intimate Partner Violence and Gender Based Violence;

AND WHEREAS gender-based violence and intimate partner violence (IPV), often referred to as domestic violence, means any use of physical or sexual force, actual or threatened in an intimate relationship, including emotional and/or psychological abuse or harassing behaviour;

AND WHEREAS on August 16th, 2023, Justice Minister Arif Virani described gender-based violence as "an epidemic" in the federal government's formal response to a coroner's inquest, also stating that his government is committed to ending the gender-based violence epidemic "in all its forms, and is working to address any gaps in the Criminal Code to ensure a robust justice system response";

AND WHEREAS by declaring gender-based violence and intimate partner violence an epidemic, the Town of Kearney can join the growing number of municipalities and regions in demanding action from all levels of government to address this growing epidemic;

AND WHEREAS the incidences of gender-based violence and intimate partner violence have increased exponentially throughout the COVID-19 pandemic and has not decreased, while funding to provide the growing demand of services and support for victims and survivors has not kept pace;

NOW THEREFORE BE IT RESOLVED THAT the Council of the Corporation of the Town of Kearney declare intimate-partner violence an epidemic, as per recommendation #1 from the Culleton, Kuzyk, and Warmerdam (CKW) Inquest;

AND FURTHER, that the Town of Kearney supports the Town of Orangeville, Dufferin County Council and the Orangeville Police Services Board resolutions and all future calls

for municipal support recommending that gender-based violence and intimate partner violence be declared an epidemic in the Province of Ontario;

AND FURTHER, that the Town of Kearney requests that the Federation of Canadian Municipalities (FCM), the Association of Municipalities of Ontario (AMO), and all municipalities and regions in Ontario declare gender-based violence and intimate partner violence an epidemic;

AND THAT the Deputy Clerk be directed to send a copy of this motion of support to the Orangeville Police Services Board, Town of Orangeville, Dufferin County, the Honourable Premier of Ontario Doug Ford, The Right Honourable Prime Minister of Canada Justin Trudeau, and our local representative Member of Parliament, and Member of Provincial Parliament.
